### a. General Lease Updates (verbal)

Kirk Taylor, Director, Real Estate Services, City of Richmond provided a verbal update on the Oval's current leases. The LifeMark lease is expiring in October 2020 and preliminary discussions are underway for a 2-year renewal, with possible longer terms to be explored. The new Oval café started business just before COVID-19 and has remained closed since mid-March in response to the Pandemic. Staff are working with the café operator Truffles on a reopening plan in the next 30 days and looking forward to a successful restart in this partnership. The Board will be updated if new information is received on both leases.

### b. Restoration of Services Update (presentation)

Andrew Clark, Senior Interim Manager Oval Experiences provided an update on resumptions of services about 8 weeks since reopening on July 2, 2020. The presentation included visitation analysis related to offerings in fitness & sports, efforts on membership activation and sales which are trending positively. Some modifications from the initial plan presented in June were made according to operational needs, provincial orders and capacity management. It was noted that the front line staff and the whole Oval team stepped up and contributed to keeping the resumption of services as seamless as possible for our members and visitors.
