The Pandemic closure that began in March 2020 provided the opportunity to accelerate pre-existing plans for online sales. This allowed the Oval Sport Store to meet shifting purchasing behavior, while adding value to Oval services and supporting Oval user groups. The chosen system, Shopify, is built specifically for Point-of-Sale and eCommerce, and is intuitive and user friendly.

Staff are encouraged to explore the integration of eCommerce to the Oval app and ability to sell tickets when hosting events.
